Payment through Paypal outside EU

- Payment term of **14** days after invoice date (see our Payment Terms and Conditions)

If payment is not made within 14 days the publication will be taken offline and placed in concept. After 30 days the article will be deleted. Regio Online Nederland cannot be held liable by the customer for damages or claims arising from this.
